HOW TO USE:

Eff Off may be applied by brush, dip or spray. (When spraying, use as coarse a pattern as possible to avoid inhalation of mist). Allow to soak for several minutes and rinse thoroughly with water. Repeat application may be necessary if heavy accumulations are present.

Note: Some types of stainless steel, chrome plating, porcelain on steel and polished decorative aluminum may be discolored. Test before using. Do not use on magnesium or zinc (galvanized). Plastic or polyethylene sprayers and buckets are recommended for application.

PRECAUTIONARY STATEMENT:

Do not breathe dust/fume/gas/mist/vapors/spray. Wash hands thoroughly after handling. Do not eat, drink or smoke when using this product. Wear protective gloves/protective clothing/eye protection/face protection. Store locked up. Dispose of contents/container according to local, state and federal regulations.

FIRST AID:
